8. Library

ICWA Library is gradually recovering its glorious heritage as a premier store house of information and data related to foreign affairs. Library's membership has substantially increased, and in March 2010 it touched 760. The automation and computerization work in the Library began in early 2009. About 75,000 books have already been entered in the system. The catalogue of the books will be available online by March 2011, which will give researchers the facility of accessing the Sapru House collection. The Library has now memberships of esteemed institutions and reputed national and international professional bodies viz. DELNET, IASLIC, IFLA etc. These memberships are optimally used to seek information or borrow material for our Research faculty and research students.

ICWA receives queries from American Centre, British Council, India International Centre, Nehru Memorial and Museum Library, Central Secretariat, DELNET and various other renowned libraries. Media personnel of prestigious newspapers have been visiting the library for information. A large number of books are being added to the collection such as books on key issues in international affairs and foreign policies pertaining to Africa, South Asia, Central, East and West Asia etc and on themes such as Energy Security, Environment and Climate Change, Global warming etc. Professors and Research scholars alike from reputed Indian Institutions and Universities have referred to the books, periodicals and press clippings available in the library. Work will soon start for creating the digital content of the immense and valuable treasure available in the ICWA library. The press-clippings of approximately 10 Lakh in number, bound volumes of newspapers of a major Indian daily from 1964 onwards and

approximately 700 rare books will be preserved through digitization and will be made available online.

11. Research and Analysis

The ICWA continued to build its research activities by increasing the research faculty in August 2009 from two Fellows to seven including a Director (Research).

During the period under review, the research faculty members focussed on the study and research on the political, security, and economic trends and developments in Asia, Europe, United States and the wider global geostrategic and economic environment.

ICWA Fellow authored several Issue briefs, Policy Briefs, Viewpoints on regular basis which were published on the ICWA website. The ICWA has started publication of Sapru House Papers that are designed to provide in-depth analysis of key foreign policy issues to stimulate debate and discussions. The first Sapru House Paper is titled *Indonesia: Democracy, Military and Islam*.

The ICWA scholars actively participated in international conferences and presented papers both in India and abroad, contributed papers to Indian and foreign scholarly journals, and took part in workshops, lectures, and seminars. The above activities have resulted in academic networking, promoting synergy in multi-disciplinary research and in expanding ICWA's research capacity and profile.

Besides individual research, the scholars engaged in numerous activities including coordination and organization of conferences, public lectures, round tables and seminars.

In January 2010, Dr Jyotsna Bakshi joined ICWA as a Visiting Senior Fellow with funding from the Indian Council of Social Science Research (ICSSR), New Delhi.
