6. The publishers should also have the capabilities to publish e-books on prime networks, particularly on International Relations/World Affairs. Please share relevant details.

9. Copies of Income Tax Return of last three years, if PAN Card is not in the name of the firm.

1. Every Publisher shall have to register with the Indian Council of World Affairs before undertaking business with the Council.
2. The Publisher shall submit the copy of their IT returns for the last three years and PAN and GST no. in the prescribed application form along with the address proof.
3. The firm order shall be acknowledged and executed up to the specified date, failing which, it would be deemed to be cancelled.
4. The Director General, ICWA's decision in all the exceptions to these terms and conditions shall be final and binding on all concerned.
5. All legal disputes, if any, shall be settled in Delhi.
